## Letter from the President and Board Chairman

Dear Friends,

This year we celebrate 150 years of YMCA service in Atlanta! That in itself is quite an accomplishment and a distinguished measure of success. YMCAs are centers of community identity and activity. But, what makes a great YMCA? You. You are central to the YMCA mission of providing programs and services which develop spirit, mind, and body. You are the face of the Y.

In sharing some 2007 highlights and accomplishments, you'll discover how the Metro Atlanta YMCA is a local advocate for building strong kids, strong families, strong communities. In personal stories from members, volunteers, donors, and staff members, you will see the face of the Y.

### Brighter futures

In 2007 YMCA Head Start expanded into Elbert, Oglethorpe, Morgan, and Greene counties in northeast Georgia. Now there are a total of 1,726 three- and four-year-olds throughout our service area getting a quality, YMCA early childhood foundation, an impact that will last a lifetime.

### Healthier families

Our health choices are contributing to increased rates of disease and reduced quality of life. The YMCA offers a community benefit by improving the health of its residents, especially those with high-risk factors. Youth Fit For Life™ and THE COACH APPROACH®, specific exercise support programs developed by the Metro Atlanta YMCA, are helping more than 6,550 children and 5,800 adults to become more active and to stay healthy.

### Stronger communities

Having YMCAs in diverse communities is the solution to some of Atlanta's greatest challenges. These include convenient access in spite of increasing traffic woes, helping families find a better work/life balance through quality programs, remaining inclusive with the area's increasing diversity, and offering supervised, values-centered programs for children and teens.

One of our proudest accomplishments is the balance we have achieved by locating YMCAs in our urban neighborhoods, in the suburbs, and in the outlying region. In 2007 we joined with the Butler Street YMCA to open The Villages at Carver Family YMCA on Pryor Road in the city of Atlanta. We also opened the new Summit Family YMCA in Newnan. Major expansions were completed at the Andrew and Walter Young Family YMCA in southwest Atlanta and at the Robert D. Fowler Family YMCA in Gwinnett County. We also completed the smooth transition with the YMCA of Cobb County to better serve all members.

Individual donors, foundations and corporations continue to support the Metro Atlanta YMCA through contributions that help to meet our community's most pressing challenges. The Goizueta Foundation, The Atlanta Falcons Youth Foundation, Benjamin F. Brady Charitable Foundation, and other donors support local residents by helping to provide quality Y programs, well-trained staff and top-notch family YMCAs.



What we accomplish in one year - or in 150 years - is the result of our collective impact. We remain committed to planning for the Y's future and are in the midst of an \$84 million Partner With Youth Comprehensive Campaign, with \$34 million already raised.

Our true impact is measured by members like Deborah who live their lives according to the Y's Judeo-Christian heritage and values. It is measured by Erin, Denny and other volunteers along with donors like Phill who commit themselves to caring for society. It is measured by Safiyah and other staff members who teach young people the importance of becoming leaders to solve current day challenges and to create a better future for their own children. 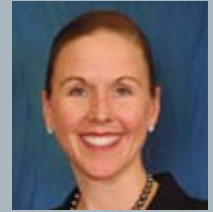

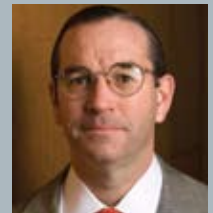

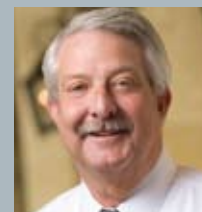

Water has defined the Grimes family for the last three years. Hurricane Katrina displaced hundreds of thousands, including Deborah Grimes and her two sons. With hope in her heart for a new start, she chose Atlanta as her new home and was welcomed into the Y family. Partner With Youth financial assistance offered hope and support during a time of hardship. Today, her boys know how to swim, and Deborah raises funds for the Y's Partner With Youth annual campaign and volunteers with several programs. Here's her remarkable story.

**W**ater - as a destructive and healing element - has defined Deborah Grimes' life for the last three years.

In August 2005, she was living in New Orleans when Hurricane Katrina's storm tide surged through. She was not allowed near her home in the suburb of Algiers until three months after the storm.

With few options - and two boys to care for - Deborah contacted an on-line placement service and chose Atlanta as her new home, a place to which her parents refused to let her move when she was younger. "I said, 'take a dart and throw it anywhere, as long as it is safe,'" she recalls.

While her youngest son, Octavious, started at a new school, Deborah and her oldest son, Gary, looked for permanent housing. She hadn't slept in what seemed like weeks. Still, she wanted to find a place where her sons could take swim lessons. A new friend referred her to the Cowart Family/Ashford Dunwoody YMCA. There, she applied for and received financial assistance to provide a constructive outlet for her family in transition.

Water brought her family together again, healing them after months of struggle from the great deluge. "I will never forget the Y for teaching my boys how to swim," Deborah says glowingly. "My little guy, he swims like a fish - he loves the Y."

Gary returned to New Orleans for college, and Octavious continues to swim and plays soccer at the Y. Deborah, who had major back surgery and two operations leading up to it, can be seen in the community raising funds for the Y's Partner With Youth annual campaign and volunteering for YMCA teen and family programs.

She credits the generosity of the Y family and Atlanta's family-oriented atmosphere for her family's success three years later. "I should have been here 20 years ago, but the opportunity opened up after the storm," Deborah says. "I was destined to be here. The YMCA is awesome for quality, family time."

As head of a charitable trust that has given significant gifts to the YMCA, Phill Bettis positively impacts the lives of countless kids involved in Y programs. But, his generosity has a more expansive purpose: To become active in the lives of what he dubs the world's most important generation since World War II, so the future will be something to embrace rather than to fear.



Last summer at Eagle Point Day Camp, the Forsyth County Family YMCA's summer camp on Lake Lanier, Phill Bettis watched an excited group of kids listening intently to their counselors and asked himself a scary question: What if the YMCA didn't exist?

His description of that alternate universe is fascinating. "The lack of a Y for these children removes a light that is replaced by video games and inactivity, where mentors are non-existent, and the view is four walls instead of God's creation," he says.

For Phill, today's youth face important challenges - America's place in the world being the most daunting - and is thus the fundamental reason why a charitable foundation he oversees generously donates to YMCA youth programs.

"This generation growing up right now is the most important generation in terms of the future of the world," he says. "It's very important that we reach

our young people. The YMCA does a great job of teaching and encouraging the development of lifelong values, leadership skills and volunteerism to today's teens."

Soft-spoken and humble, the Forsyth County attorney helps to oversee the Benjamin F. Brady Charitable Foundation, which funds education, health care, children, and religious causes in North Georgia.

Phill met Mr. Brady when he was finishing college in the 1970s and formed a lifelong friendship. More than 20 years later, after Mr. Brady's wife passed away, he asked Phill to help him create a charitable foundation.

"Mr. Brady was a friend, a mentor and someone who showed confidence in me at a young age," Phill says. "I don't forget those people in my life, because they are one in million. Mr. Brady also had a big picture look at needs in our community, and I find that even rarer."

Along with James Myers, Eric Chofnas and Ronnie Pilcher, the other Brady Foundation trustees, Phill committed transformational gifts to the Forsyth County Family YMCA. The gymnasium is named in Mr. Brady's memory, and a gift was made to the Eagle Point Day Camp. "The YMCA does a great job of meeting the needs of the community, so we are happy to help the Y build strong kids, families and communities," he says.

In Forsyth County, Phill Bettis' name is synonymous with giving. In 1999 he served as member of the steering committee to establish a YMCA in Forsyth County. The campaign raised more than \$3.2 million, \$600,000 of which Phill personally raised to build the new family Y, located in Vickery Village.



With the odds stacked against her and her family, Safiyah Pankey left Queens, N.Y., with just \$10 in her pocket and a dream of a better life in Atlanta. She made her great escape and began a new journey with the help of the Decatur-DeKalb Family YMCA. There she found a sense of belonging and a strong sense of community. Her can-do spirit rejuvenated her family and lifts the spirits of everyone who visits the Decatur-DeKalb YMCA.

In 1999 Safiyah Pankey had enough of Queens, N.Y. Her family, she says, was hanging by a thread. And, there was no prospect of the situation getting better without a drastic change. She found a job at a Starbucks in Atlanta and booked a flight there.

When she walked out of her apartment for the last time with \$10 in her pocket – temporarily leaving her four children behind – she noticed a unit in her complex had caught fire. The symbolism was undeniable. “I looked back and said, ‘Well, that means we’re not coming back,’” Safiyah says. “I just kept thinking of the future.”

Getting to Atlanta proved to be a lesson in patience and faith. The flight was overbooked, and she was bumped, an alarming development given the fact she was scheduled to start at Starbucks the

following day. After spending the night in the airport hoping to catch the next flight, she began to pray. She was not going back to her former life. At the last minute, her name was called: she had a seat. Safiyah was so excited, she got in the wrong boarding line and nearly missed her flight – again.

“That airplane flight changed the course of my life,” she recalls. And how. She applied for and received financial assistance at the Decatur-DeKalb Family YMCA. Soon after, she began working the 5 a.m. front desk shift, which helped her to establish a support network. Her children – Kwesi, Rashid, Precious, and Kiel – eventually moved down and also became active at the YMCA. “I thought it’d be a great place for the kids, especially since we didn’t know anybody,” says Safiyah.

Nine years later, it’s as if her life in Queens was someone else’s. Safiyah now serves as member involvement coordinator at the Decatur Y and prides herself on paramount customer service and a holistic approach to health and wellness. This attitude is reflected in small details like e-mails, where she ends a quick note with the simple phrase: “Peace and love multiplied.”

“I think the Y is about lifting people’s spirits more than anything,” Safiyah says. “I focus on getting people to the Y, informing them about various Y programs like the Partner With Youth annual campaign that raises money for financial assistance to help families during difficult times, and sticking to the YMCA’s mission of developing each individual in spirit, mind and body.”

Today, Safiyah’s family is solid. Her oldest son returned to New York, where he is raising his family. Her three other children remain in Atlanta. Safiyah loves to sing, dance, read, and laugh with her six grandchildren. And, she found kindred spirits in Conundrums, an African drumming group formed with her ‘sister friends,’ which performs throughout Atlanta.

“I love the Y,” Safiyah says. “The Y totally supports me and totally supports my children. I know so many people at the Y now: it is my family.”

A strong father-daughter relationship is beautiful, especially in the case of Denny and Erin Collins. When Erin was a little girl, she and her father bonded through the McCleskey-East Cobb Family YMCA Adventure Guides program. Undoubtedly, the lessons learned have proven worthwhile. Erin is headed to college this fall. She and her dad continue to serve as Adventure Guides volunteers, leading a new generation of children and parents in building stronger ties and stronger families.

**D**enny Collins has what many parents only dream of: a teen he never has to worry about.

After all, Erin, a 17-year-old student at The Walker School, has top universities knocking down her door, a supreme confidence that adults instantly recognize, enviable leadership skills, and an iron will to avoid many pitfalls that define modern-day adolescence.

Even better, she has the love and affection of her father, who has seen her grow from a shy girl into a beautiful, young woman, due in large part to their eight years of involvement with the McCleskey-East Cobb YMCA Adventure Guides program.

Erin and her dad began Adventure Guides when she was a shy eight-year-old, and he was a busy financial executive. From canoeing and camping trips to sharing a few of life's more tender moments - Erin's first slow dance was with her father - an impenetrable bond was forged.

"We're so busy trying to make money to pay mortgages and to put food on the



table, we almost forget the most valuable thing we can give our children is time," Denny says.

When Erin and her father graduated from the program four years ago, they were asked to continue their involvement as Adventure Guides volunteers. They are leading a new generation of parents and children to find common ground. In the process, her father says, Erin is growing into an engaging leader who is being courted by some of the nation's top business schools.

As a volunteer Erin effectively leads hundreds of adults and children during Adventure Guides retreats, something her father says many adults could not accomplish. "This meek, very timid little girl now can speak in front of 500 people and not bat an eyelash," Denny says. "I can't help but sit back and say, 'wow.'"

Erin says she 'found' herself these past four years, gaining a confidence that supersedes the need for drugs and alcohol. This impacts her relationship with her dad. "I can tell him anything about my life," says Erin, who is considering a degree in international business. "I know if I need help, I have a really great support system at home."

Her father agrees. "When kids and their parents have good relationships, there are a lot less problems in this world," he says. "I'm not worried about my 17-year-old daughter, because I know her well. She has great judgment; she has a great head on her shoulders. She's going to make mistakes in life - we all do, it's part of life - but, she's not going to make the big ones. Not only am I proud of my daughter, but I am proud to know my daughter."



# '07 Impact

Guided by our Y-2010 strategic plan, the Metro Atlanta YMCA focuses on the solutions to vital, community issues like childhood and adult obesity; constructive activities for kids when they're out of school; affordable and accessible early childhood education; and helping teens to become responsible adults. It's where you can engage in meaningful involvement that results in collective, community impact.



### **YOUTH SPORTS AND RECREATION**

Helped to address childhood obesity and build a life-long appreciation of health and wellness in 48,169 children through participation in values-based physical activities that build skills and self-esteem.

### **PRE-SCHOOL AND HEAD START**

Helped 2,208 children prepare for kindergarten by providing a quality, early childhood learning foundation.

### **AFTER SCHOOL**

Gave 7,581 children enriching activities during nonschool hours in a safe, supervised, affordable, and accessible program. Increased physical activity and reduced health risks in youth by offering Youth Fit For Life™ at after-school sites, YMCAs and at schools during physical education classes. Operated 117 after-school sites.

### **RESIDENT CAMP**

Used challenging outdoor experiences to help 3,554 young people grow emotionally, mentally, physically, and spiritually.

### **DAY CAMP**

Offered a place for 15,285 youth to go when school is out, to build relationships and enrich their understanding of the outdoors while having fun in a secure setting.

### **YOUTH DEVELOPMENT**

Helped to develop 6,971 teenagers by guiding them with positive, adult role models, involving them in leadership development activities and community service programs, and preparing them to become future business and community leaders.



### **FINANCIAL ASSISTANCE**

Enabled 28,297 children, families and adults with \$38.2 million of financial assistance for Y programs like child care, Head Start, camp, youth sports, and teen development. Provided \$2.9 million in Partner With Youth annual campaign assistance.

### **YOUNG PEOPLE WITH DISABILITIES**

Offered an opportunity for 453 young people with physical impairments to play team sports and learn to swim. Happy Club outings gave 210 young adults with developmental disabilities time away from family, social interaction, recreational activities, and a chance to learn new skills.

### **WELLNESS**

Progressively involved, supported and empowered 152,218 individuals in the pursuit of health enhancement and the reduction of obesity and related chronic diseases. Continued research on the impact of THE COACH APPROACH® exercise support process for new and returning exercisers and those most at risk.

### **VOLUNTEERS**

Involved 4,864 men, women and young adults as volunteers in different programs.

### **COLLABORATIONS**

Avoided the duplication of programs and services by collaborating with more than 100 government, health care and community service organizations including Atlanta Housing Authority, DeKalb County Schools, Northside Hospital, and American Association of Adapted Sports Programs, Inc. (AAASP).
